

## HALFWAY CREEK LUTHERAN CHURCH ANNUAL MEETING - February 2, 2025

- I. Call to order @11:07 by VB President Patti Happel. Quorum established with 42 HCLC members signed in.
- II. Motion made and seconded to adopt agenda as published. Motion passed.
- III. Opening Liturgy by Patti Happel, bible reading from 1 Corinthians 12.
- IV. Motion made and seconded to approve minutes of February 4, 2024 annual meeting. Motion passed.
- V. Motion made and seconded to approve the minutes of August 4, 2025 congregational meeting. Motion passed.
- VI. 2024 Ministry Review - Motion made and seconded to accept all reports of teams and ministries as published in the annual report. Motion passed.
- VII. 2024 Financials
  - A. Income and Expense Report reviewed by Bookkeeper Jodi Anderson.
  - B. Jodi gave an overview of the proposed 2025 budget and answered questions. Motion made and seconded to adopt the proposed budget as published in the annual report. Motion passed.
  - C. Thank you to the congregation and our friends for their generosity in weekly offerings, debt reduction, and replenishing Thrivent and Dedicated Funds.
- VIII. 2025 Ministry Plan
  - A. This past week you received a letter indicating that the VB has hired Patti Happel for 15 hours per week beginning March 1, 2025 as a Synod Authorized Minister (SAM). We will continue to use supply pastors as we can and Patti's role will supplement that and provide leadership for programming and pastoral care.
  - B. New Vision Board members elected by paper ballot include: Michelle Olson and Wayne Atchley. Emma Nedoba and Olivia Nedoba will join the Vision Board as Associate Members/Advisors. There were no nominations from the floor.
  - C. Thank you to outgoing VB member: Kari Washburn.
  - D. Anyone interested in attending synod assembly in June, please let a member of the VB know.
- IX. Motion made and seconded to adjourn the annual meeting. Motion passed. Meeting adjourned at 11:38
- X. Closed with the Lords' Prayer.

# Constitution Changes

At the annual meeting, the congregation will be voting on changes to the HCLC Constitution and Bylaws. The following is a summary of the changes. The changes were shared with the congregation with the January newsletter. They were in a separate document included with the VB meeting minutes of December 14, 2025. **Motion 1: Model Constitution Amendments** - These amendments were prepared by the Office of the Secretary of ELCA in follow up to Church-wide Assembly of the ELCA this past summer. The following is a brief summary of the changes. The Model Constitution for Congregations of the Evangelical Lutheran Church in America is a key component of the congregation's governance. Each church-wide assembly of the ELCA has amended the Model Constitution for Congregations. Each ELCA congregation is encouraged to review these amendments, to incorporate changes to required provisions into their constitutions and to consider recommended changes. Changes made this past summer were reviewed and approved by the Vision Board. We are bringing them forward at the Annual Meeting for approval by the congregation.

1. Several updates were done to: insertions for comprehensiveness, consistency with language in other parts of constitution, reformatting, restore a phrase omitted in a previous assembly, or as a cross reference to the model constitution instead of local synod constitution.
2. \*C5.04. - Allow a council to elect on Synod Assembly representatives instead of the congregation. NOTE: We were already doing this if no one was elected.
3. \*C9.06. At the time of a pastoral vacancy, an interim shall may be appointed. Rationale: Not always possible to assign an interim.
4. \*C9.15. - Was not previously a required provision. Under special circumstances..... a Minister of Word and Sacrament of a church body with which the ELCA has established a relationship of full communion may serve temporarily as a pastor of this congregation....

**Motion 2: Amendments to the HCLC Constitution** - Throughout the fall the VB did a review and is recommending several updates. Our constitution indicates in \*C16.02. An amendment to this constitution shall: a. Be approved at any legally called meeting of this congregation by a majority of those voting members present and voting; and b. Be ratified at the next regular meeting of this congregation by a 2/3 vote of those voting members present and voting. If approved at the Feb. 1, 2026 annual meeting, they can be ratified at the next congregational meeting. The following is a summary of the changes:

1. ADDED: C9.32. Consistent with the faith and practice of the ELCA conduct of Synod authorized Ministers will be held accountable to the Definitions and guidelines for Discipline of rostered Ministers. It goes on to describe what a SAM is called to do.
2. ADDED: C9.33. The specific duties of the SAM, compensation, and other matters pertaining to the service of the SAM shall be included in a contract, which shall be attested by the Bishop of the synod.

NOTE: Both of these amendments were reviewed and endorsed by the Bishop.

3. C10.02. And C10.03. Updates done for consistency in language with other parts of constitution.  
C12.01. And C13.08 - Update done in 2022 model constitution that did not get in about defining "ex-officio".

4. C12.05. The Vision Board shall be responsible for the financial and property matter of this congregation.

a. In C. And D., amounts were increased when the VB could make decisions. Updates had not been done in several years.

b. G. Eliminated Financial Secretary role, as we have a Financial Assistants staff role.

c. C.12.07. Annual review of membership to be done every three years instead of one. Note: This was done in 2025.

5. Chapter 13 Congregational Committees - Eliminated Nomination and Mutual Ministry Committees. Updated Executive and Audit committee responsibilities. We added the Property Team and Music and Ministry Team.

## Music and Liturgy Team

During 2025, we were blessed to have our worship services led by Patti Happel, our SAM, one of our own members, Ron Christensen, and some wonderful supply pastors. Here is a summary of worship highlights from 2025:

- On January 19, Pastor Kathryn Thompson from LuMin Campus Ministry shared a message around the theme of “thresholds” during worship.
- Bishop Malpica joined us for worship on March 9 at the installation service for Patti Happel as our Synod Authorized Minister.
- Our mid-week Lenten services began in March, and discussion was based on the book “The Great Spiritual Migration: How the World’s Largest Religion is Seeking a Better Way to Be Christian” by Brian D. McLaren.
- In April, our Sunday School children shared special music with us on Easter Sunday.
- On May 4, we confirmed six of our youth.
- In June, we transitioned to our summer worship schedule with one service at 9:00 am.
- On September 7, we joined the other Holmen area ELCA churches for God’s Work, Our Hands Sunday and worshiped at the Halfway Creek Park Bandshell.
- On September 21, we had Blessing of the Bibles during worship.
- We held an outdoor Pet Blessing on October 5 in honor of the Feast of St. Francis.
- On Reformation Sunday, October 26, we celebrated the *Thanksgiving at the Retirement of a Debt* during our worship service followed by a delicious meal.
- In November, we celebrated with a Gratitude and Giving service with other area churches. We assembled almost 100 meal kits for local food pantries.
- December included special music from our Sunday School and a Music Ministry Sunday. We recognized 13 people who shared special music during worship in 2025.
- We were also able to replace some of our sound equipment including a new mixer, microphones, cords, and mic stands. Thanks to the generosity of the congregation, we will be able to update a few more sound equipment needs in 2026.
- Our average worship attendance in 2025 remained fairly consistent compared to our 2024 average, even though we transitioned from holding two Sunday services for much of 2024 to a single service during 2025.

Thank you to everyone who helps to lead our worship service in any way. We are always looking for more people to volunteer to assist with our Sunday worship. If you have any questions regarding volunteer opportunities, please reach out to me or Patti Happel.

## Legacy/Heritage Team

The Legacy/Heritage Team was formed following the 2025 HCLC annual meeting. The focus of the team was to look at the possibility of closing our doors due to our financial position at the time. This was/is a difficult reality to face, but we know we need to be responsible and be prepared for this possibility.

The team met several times this year and we continue to meet. We met with parishioners after some Sunday services to talk about what we are doing and gather input from them. In our next meeting, we will meet with Rev. Dione Stepanek of the La Crosse Synod staff. We are not the only congregation in this synod facing this issue. Rev Dione has been working with other congregations facing the same issues as HCLC.

When we released our pastor in 2024, the Vision Board found we could not even afford to close our doors. Since that time, some remarkable things have changed here. Perhaps the most impactful has been the generosity of members and non-members to pay off our building debt. Just as impactful was the commitment made by Patti Happel to become our Synod Authorized Minister. (SAM) Between Patti and our supply pastors, we have been able to continue weekly services.

Since the release of our pastor, the paying off the debt, and the structure we are using to continue to provide pastoral services at Halfway Creek, we are currently financially stable. However, the team will continue to work on how we may leave a legacy if circumstances like what happened in 2024 will force us to face a reality, that our continued mission at HCLC may become unsustainable. We hope to present a full report to the Vision Board and the congregation later this spring.

## Property Team

2025 was a busy time for the property team. There were many projects to complete before winter.

A tree service company was hired to remove trees that were dead or dying. Some trees were along the power line at the north end of the parking lot. The company removed the trees and hauled away the branches and wood for us. The crabapple trees were trimmed, and debris was hauled away by the property team.

Our culverts at both entrances were not functioning properly, we called the County out to trench out the ditches so water could flow again.

The gutters continued to have a problem of getting plugged from pine needles. Screens were installed to prevent that. No more climbing ladders!

There was a water leak in the roof that was leaking onto the computers at the back of the church. Hired a boom truck to come out and fix the leak.

The windows in the worship area had rotting wood which was causing cold air to leak in. We removed the trim and found large areas of rotted wood in all the windows. We sealed up the holes and replaced the trim with new wood.

We finally painted the ramp at the back entrance of the church. Thanks to Rich, Dan, Kent, and John for helping, and thanks to the office ladies for lunch.

A new entrance door was purchased for the back of the church; the old one was rotted and in bad shape. Rich and Stan helped unload it. Rich helped me paint it. Kent, Dan, Rich, helped install it. I still need to finish the trim on the inside.

This fall we were informed that both furnaces in the basement needed to be replaced. With a donation from a member, we were able to complete the installation before it got cold. Many thanks to the donor.

The patio door in the parsonage was warped and leaked air. A new door was bought and installed by Clear Choice Windows.

There was a lot of work put into cleaning up the grounds, Brush and undergrowth were cleared and removed from the property. One of the drainpipes for downspouts was extended to keep it from washing out our neighbor's property.

The garden was moved to a new location this year to make it easier for the ladies to do their work. Thanks to Archie for the use of his truck to haul in the soil.

It takes a lot of effort to make our church grounds look nice, thankfully we have a dedicated group of members that devote themselves to that mission. This year Rich has led our little group by arranging companies to come in to remove the trees, and roof repair. Recruiting help for major work around the grounds. If you drive by the church, you'll more than likely see him at the church working inside and outside. He's a dedicated grass trimmer; he's always weeding and trimming the grounds. Rich along with Dan have been a huge help in taking over projects that I was unable to attend this year due to personal issues. Also, thanks to Dan, Kent, Archie, John, Stan, Wayne for your dedication and help.

## **Loose Offerings Make a Difference in 2025**

Each Sunday, we ask you to put your change (and bills/checks) in the cake pan and to "Make some NOISE!" Over the past year, you have "Reached Out to Share Christ with All" and have made a difference within our church, our community and throughout the world. Let us show you how...

**Within the church:** We started our loose offering campaign by collecting for the Quilting and Gardening Ministry. In April, we used the offering to support Outreach Ministries. We did things like sending boxes of treats in the fall to last year's graduation class. We took treats to area 1st responders thanking them for the work they do. We also had water and treats for the participants of the jazzercise classes who met here at the church several times a week. We also gave a donation to the Halfway Creek Cemetery.

As we begin 2026, the Vision Board would like to hear from you if there is an organization that you volunteer for or a cause that is important to you, that we should consider for our "NOISY" loose offering. In January, we collected for the Warming Center, an organization that provides overnight

housing during the cold months to our homeless community. Lacey Hein came to speak to us about the program. We will continue to try to have a representative of the organization we are collecting for join us during worship services. We are currently “making noise” for LuMin Campus Ministry.

## Befrienders

The Befrienders are a group of individuals that are an extension of the Lord’s Table by providing Communion to individuals that cannot physically be present in worship. We currently have four routes of 1 to 4 people that we visit in their current home. Three of our routes take us to long-term care facilities. Each route is visited by a Befriender Team of 2 each month. Sometimes a physical visit just doesn’t work, but even a call can make a difference for someone. Each visit includes a Bible reading, a prayer, communion and the Lord’s Prayer. Of course, visits always include some socializing and giving updates on the church.


This is a very important ministry for some of our congregational members. If you know of someone who would benefit from this ministry or you want to get involved as a Befriender, please leave a message in the church office.

# Technology Team

The main goal of this group is to assist and support Halfway Creek in utilizing technology in a manner that supports the vision of "reaching out to share Christ with all."

## **2025 Happenings:**

- The new network that was installed in late 2024 is faster and has been working without issues.
- The Sunday worship livestream has been working without issues after a late 2024 card replacement and some best practices developed and put in place regarding use of the worship computer.
- The entire area in the back of the sanctuary where the PowerPoint and livestreaming reside was cleaned up and organized. The results are beautiful and much more user friendly.
- An office doorbell and open-door bell were installed that ring in the office. This was not only a need for the office staff to know when people are coming and going but has increased security for the office staff.
- Microsoft Windows 10 became obsolete, replaced by Windows 11. One of our existing computers was already up-to-date, one of our existing computers was able to be updated, and one of our computers had to be replaced as the computer itself was too old to be updated. The new computer was placed in the Pastor's office and is now shared between Patti and Jodi.
- Microsoft changed their licensing structure which made us to either pay a yearly fee for our computer-based software or switch to the new free online office365. The switch to the online version was made and after a little learning curve we have had a successful switch.
- The music team and technology were able to replace our twenty-five-year-old sound board with a new one along with new microphones.

All of the above actions were able to be accomplished through several generous donations by several members. Thank you to everyone.

## **2026 Plans:**

- o Microsoft Publisher is being phased out in October with no actual replacement provided. Shari currently uses this software to create bulletins and newsletters. Shari is looking into options that will work for her along with a decision on how or if we retain her past work and what it would take to convert it.
- o Shari's computer is getting older and will look into possible replacement.
- o Look into the types and cost of security cameras and possible installing some or maybe in 2027.

2025 was a very busy year for the technology team but successful. 2026 is shaping up to possibly be a busy year as well. The technology team would like to thank the congregation for their ongoing support, which helps us keep the church running smoothly.

## Safety Team

Earlier in 2025, the Vision Board discussed the need for developing emergency preparedness procedures for our parish. Simultaneously, the La Crosse Area Church Security Network was formed, and we have attended some of these meetings as well.

The focus of our Safety Team is multifold, with consideration for procedures to help us better prepare for and respond to medical events, fire hazards, and active intruder situations. We are actively working with our insurance provider to assist us with planning that is aligned with our insurance coverage and requirements.

We anticipate that the work to develop these procedures will be ongoing throughout 2026 with the goal to have written plans in place by the end of the year. Stay tuned!

## Financial Report

2025 was an exciting year for the finances of Halfway Creek Lutheran Church. We are pleased to report that offerings remained consistent with the previous year, with contributions from members and visitors totaling \$160,056. This generosity allowed us to exceed our annual budget by \$406, providing a stable foundation for our various ministries.

The most significant milestone of the year occurred in July, when the mortgage loan on our building was paid in full to Merchants Bank. We extend our deepest gratitude to everyone whose dedicated contributions made this achievement possible. Because of your commitment, Halfway Creek ended the year debt-free and with positive bank balances.

Looking ahead, this financial freedom has allowed the Vision Board to establish a new Maintenance Fund dedicated to the long-term care of our church property. For the 2026 budget, the Board has allocated \$1,000 per month to this fund. To ensure these resources are managed effectively, the funds are being held at Thrivent to take advantage of higher interest rates. We enter 2026 with a renewed focus on stewardship and excitement for the future of our facility. – Jodi Anderson, Bookkeeper
